Under the heading strengthen our connection with nature there are several other policies, actions and future priorities we would like to see included.

These are: create a nature-rich countryside as well as a nature-rich urban environment, create better/cheaper public transport to nature-rich countryside, especially for those on low incomes living in disadvantaged areas, create National and Higher exams in Ecology, boost adult education opportunities in Ecology and Natural History, create 3-year apprenticeships and full-time jobs in practical nature restoration, especially in complex systems such as temperate rainforest, Caledonian pinewoods and coastal marine ecosystems.

Under the heading Empower Scottish people to live well sustainably: support communities to grow food locally - in other words, support the growth of horticultural systems run by and for communities, including funding full-time jobs. Also create local food hubs where food can be brought in bulk and distributed, local surpluses can be made available and supermarkets can offer food which has reached its best-before date.

# Outcomes on biodiversity, climate change and pollution

Nature restoration of Scotland's ecosystems results in carbon sequestration as well as increasing biodiversity. Carbon sequestration reduces the impacts of climate change by drawing carbon out of the atmosphere. Note that though exotic systems (eg sitka spruce plantations) draw carbon out of the atmosphere they in no way help increase biodiversity - in fact quite the reverse.

Minimising pollution (particularly chemical - including the use of herbicides and pesticides) - and plastic) and reducing waste (we include agricultural run-off here as waste) will result in greater biodiversity and will also have the effect of creating fewer materials in the first place, which will mean less energy and materials extraction resulting in positive effects on Climate Change.

The public understanding of the climate crisis is complex. Most people understand what the climate crisis is and what needs to be done to address it, but at the same time they are not engaged enough to make significant changes to their lifestyle. It is generally seen as a long term issue which is happening so slowly as to be almost imperceptible, whereas we are programmed to deal with immediate crises. The government needs to commission more research to get a better understanding of the public's reaction to the climate crisis in order to get real engagement at grass roots level and one way to do this would be through re-instating the Climate Assembly. Without real public engagement it is unlikely there will be any meaningful change in public behaviour and thus progress towards the aims of the strategy would be in jeopardy.

There are many additional ways not mentioned in the outcome pathways that the Scottish Government can help us connect better with nature and to live more sustainably. Nature education should not just be aimed at children, but youth and adults as well. What you do not know about, you will not want to love and protect. Also, learning by doing is the best way for everyone to learn, so supporting children, young people and adults to grow some of their own food in both school and community settings should be a government priority. Similarly, apprenticeships and full-time jobs in nature restoration will also offer great learning opportunities for those of a practical bent.
