Meetings of Trustees

The Trustees had four formal meetings, one a long meeting held in Aberdeen in September and three telephone conferences in April, June and July, the ones in April and July being joint meetings with the Trustees of North Scotland Area Quaker Meeting (see below).. Other business was conducted by email, telephone and letter. The consultations and decisions taken by email communication were in fact very extensive because of various issues to do with building works referred to below.

However, it should be noted that in May 2015 Alasdair Galbraith asked to be released for reasons of ill health. In accordance with the Trust's governing document, he remains appointed as a trustee until North Scotland Area Quaker Meeting, which appoints trustees and releases them from appointment, has had the opportunity to consider Alasdair Galbraith's request to be released at a meeting for worship for business held by the Area Meeting.

Governance

The Trust is a charitable unincorporated trust and the purposes and administration arrangements are set out in the Governing Document, approved by the Office of the Scottish Charity Regulator and dated 22 April 2012.

As stated in the Governing Document, trustees are appointed by North Scotland Area Quaker Meeting at a properly-constituted Meeting for Worship for Business.

Charitable purposes

Our charitable purposes:

- a. Maintenance of places of worship and related property for which the Trust has responsibility.
- b. Payment of travelling and other expenses for individuals from within North Scotland Area Quaker Meeting (previously North of Scotland Monthly Meeting) to attend meetings organised by Britain Yearly Meeting (BYM) and other Quaker bodies.
- c. Helping individuals within North Scotland Area Quaker meeting who are in financial need.
- d. Providing financial assistance to help with the education of children of the members of North Scotland Area Meeting.

Trustee remuneration and expenses

Trustees did not receive any remuneration for their work during the year, but were reimbursed at cost for travelling and other necessary expenses involved in the attendance at the meeting of the Trust.

General Activities

At its three meetings and throughout the year, Trustees have been concerned with fulfilling the charitable purposes of the Trust. Support has been provided to a number of individual Friends and attenders under the general heading of travelling in the ministry (which is being interpreted by Trustees as attending meetings organised by Britain Yearly Meeting and other Quaker bodies), assistance to those with financial need and providing support for education of children. However, as in previous years, significant effort has been required in the maintenance of property. A greater amount of work was done during the year than in most years both to 100 Crown Street and to 98 Crown Street (Aberdeen Meeting House). We also commissioned some repair work of the walls at the Kingwells Burial Ground and a tree survey at the Kingswells burial grounds with a view to some necessary remedial work being carried out in 2015.

During 2014, the Trust spent £22,124 on property maintenance. Of that total, £10,180 was spent on 100 Crown Street, the property largely leased to a commercial tenant, and £11,944 on charitable properties, that is, 98 Crown Street (Aberdeen Meeting House) and Kingswells and Kinmuck Burial Grounds.. The work ensured that the external fabric of 98 and 100 Crown Street should need little significant attention for the next several years.

We have continued to bring the attention of members of North Scotland Area Quaker Meeting to the charitable purposes of the Trust and the availability of funds to meet these purposes. We would welcome further suggestions from members and attenders of the Area Meeting as to how we can best do this.

During the year there were several phone conferences jointly with the Trustees of the North Scotland Area Quaker Meeting to discuss the possibility of the Trust and the Area Meeting merging (given their close relationship). No conclusions were reached and discussion will need to be continued.

Financial Statement

The full financial statements for 2014 have been prepared by Marion Strachan, who has been asked to continue in the role of Treasurer, though she is no longer a Trustee. M R Associates acted as Independent Examiner. Copies of the report and accounts are available on request. The total receipts for the year came to £14,739, and the total payments came to ££29,963, leading to a deficit for the year of £15,225. At 31 December 2014 the Trust held investments valued at £44,419 and bank balances totalling £39,512. The Trust had fixed assets of £725,000, namely the properties at 98 and 100 Crown Street, Aberdeen. We have been advised that the two small Quaker burial grounds at Kingswells and Kinmuck currently have no commercial value.

Independent examiner's report on the accounts for the financial year ended 31 December 2014

I report on the accounts of the charity for the period 1 January to 31 December 2014 which are set out below.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (a) to (c) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and, consequently, I do not express an audit opinion on the view given by the accounts.
