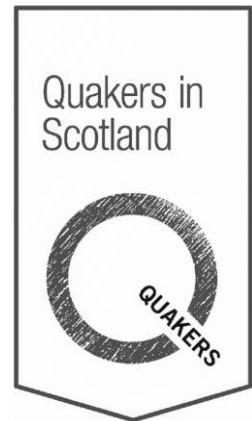

Some concern has been raised that the number of meetings suggested might not be within the capacity of Friends. This also relates to the ongoing lack of finding Friends to share the work. However, this list of dates is provisional to need as Quakers in Scotland starts its role and function. The hope is that we will have time in our meetings to work differently, with time for groups like elders to meet during the meeting, and community building, in the wider sense, take place.

Local Meetings could usefully consider how they relate to Quakers in Scotland as the new body develops and we see how we relate to each other, including through Intermediate Meetings. The incoming clerk, Adwoa Burnley, has also explained how she is meeting with QiS role-holders to consider the broader aspects of how we use our meetings.

We ask Elders to provide Friends to act as elders in future.

QiS 25/11/07 Meeting for Sufferings report

Elaine Millar, our representative on Meeting for Sufferings, has spoken to her report of the residential meeting held on 3-5th October 2025 (Paper A). Meeting for Sufferings and Britain Yearly Meeting minutes and papers can be found on the Britain Yearly Meeting website, including the annual review, annual report and financial statements.

Meeting for Sufferings accepted the laying down of East Scotland, North Scotland and West Scotland Area Meetings, and uphold Friends, “as they develop new structures that aim to help Quakerism in Scotland to thrive”. They request that Quakers in Scotland (QiS) send four representatives to serve at each Yearly Meeting as it moves to become continuing YM - where alternates are no longer required to be nominated because all Friends may attend, and in the event of a represented being prevented, alternate representation may be organised within QiS.

Elaine told us that there were three main themes for our consideration and discernment. Firstly there was discernment on the 'theological and community aspects of online and blended worship'. Secondly, Meeting for Sufferings decided to keep access to giving a 'loyal address' to the monarch. Thirdly there was an exploration of our BYM strategic priorities into the 2030s.

Elaine then referred back to the final item in her July report, about the need to tackle polarised division within Quakers. By minute 25/09/11 we agreed that we would return to this matter at this meeting. Now we learn that the proposed agenda for Yearly Meeting next May will include a key theme on handling conflict among Friends, working to overcome divisiveness and polarisation and, as a Spirit-led community, looking at ways we might work to build connections and foster acceptance and belonging. There will be preparation work ahead of YM, where Elaine hopes that as Quakers in Scotland we can wholeheartedly embrace and contribute to this work. In view of this situation, the clerks propose that we defer our consideration and wait for guidance that will come out in preparation for Yearly Meeting 1st – 4th May, and at the next two Meetings for Sufferings. We agree to this.

We thank Elaine for her report.

The clerks will contact Meeting for Sufferings representatives (Quakers in Scotland and as appointed by area meetings) to check on our representation for the last two meetings of Meeting for Sufferings.

QIS 25/11/08 Local Development Worker Priorities for 2026

Minute GMS 24/11/15 refers. Zoe Prosser's Local Development Worker priorities for 2025 as agreed with staff are listed in Paper B. Following consultation with her line manager and the QIS Clerk, Zoe Prosser has brought us the proposed priorities for 2026. These are changed slightly in order and emphasis to match the current situation.

1. Supporting Quakers across Scotland (including area meetings and Quakers in Scotland) to find good ways of working within our changing structure.
2. Supporting Quaker communities to be loving, inclusive and all age.
3. Pointing the way to information about available resources and materials, including videos and non-traditional resources, to help Quaker Meetings and role-holders identify what they need, and developing and creating further resources where there is a need.
4. Continue to strengthen and develop support for role holders.

We endorse these priorities for 2026.

QIS 25/11/09 Minute from SESAM: transatlantic slavery

We receive minute 6.3 of South East Scotland Area Meeting SESAM held 10th

September 2025 which reads as follows:

Central Edinburgh: Research into our Quaker ancestors' role in the trans-Atlantic Slave Trade and enslavement of people

We have received minute 2025/07/12 from Central Edinburgh LM:

Lancaster Quakers have issued an apology and have announced a series of other actions following research into their involvement with the trans-Atlantic slave trade and enslavement of people.

Our Friend Mark Bitel, who is a member of the City of Edinburgh Council Legacy of Slavery and Colonialism Implementation Group has asked us "Is it now time for Quakers in Edinburgh and South-East Scotland to undertake research into the involvement of our Quaker ancestors in enslavement?"

He suggested we send this concern to Area Meeting, with the related suggestion that we could apply for a small research grant (circa £5K from the Sylvia Marshall Bequest Fund) to fund a specialist researcher at a university to undertake this research on our behalf.

While recognising concerns related to the issue of research relating to past involvement in the trans-Atlantic Slave Trade and enslavement of people, Friends supported the concern and the proposal that research should be undertaken. Dan Dickson expressed her willingness to contribute to this research. For the question of funding though it was agreed that discernment of this be moved to a later meeting. Clerks will forward this minute onto the Clerk of Area Meeting.

We agree to adopt this concern; we agree to invite the new Quakers in Scotland body to consider it as a Scotland-wide concern. We thank Central Edinburgh LM for bringing it forward.

a) Rosebank Oilfield and genocide in Palestine

On 24th September 2025, the Parliamentary Engagement Officer signed, on the authority of the clerk, an open letter to Stephen Flynn MP about the link between the genocide in Palestine and the Rosebank Oil Field. This letter was co-ordinated through Uplift.

b) Rosebank Oil field

On 23rd October 2025, the clerk signed a further letter, with others, to the Prime Minister urging him to reject the development of the Rosebank Oil Field in the North Sea. This letter was circulated with the last 'wee update' from our Parliamentary Engagement Officer.

I'm a young adult Friend and member of Stillwater Monthly Meeting, Ohio Yearly Meeting (Conservative), and Peter is a member of Mt Toby Monthly Meeting, New England Yearly Meeting, and a teacher at Pendle Hill Quaker Study Center. We have felt a drawing to visit you all in love, to see and feel how the Divine Teacher is working there, and to see if we might be of use by following the leadings of that Teacher among you.

Peter and I would hope to visit you for your general meeting, not with any agenda or plan, but just to learn with you all from our dear Guide. We know that traveling in the ministry in this way has become uncommon among Friends, so we'd be glad to share with you all about what this means for us and what we've been learning along the way, if an opportunity for that arises.

Matt and Peter will be supported by Lia den Daas, who has felt a leading to join Matt and Peter in visiting us. Lia is a young adult Friend from Jesus Lane Meeting in Cambridge.

In our opening worship we were reminded by the travelling ministers that the way forward is not always clear, especially in such a difficult world. It takes courage to follow the leadings of God when they direct us towards the paths we are set, even if we don't understand why we go that way. But God is with us all the way and we are held. We can listen to that still, small voice. Thus we go where we are led, in a continuing adventure. Other ministry made the observation that 'God' may even be understood as a verb.

QiS 25/11/13 Saturday agenda

QiS 25/11/14 Crynwyr Cymru - Quakers in Wales

Crynwyr Cymru - Quakers in Wales held a meeting online 25 October and recorded the following minute:

We welcome these greetings and ask the clerk to write to the clerks of Crynwyr Cymru - Quakers in Wales.

QiS 25/11/15 Membership transfers

Further to minutes QiS 25/09/02 and QiS 2025/11/05, we accept further memberships transfers to Quakers in Scotland as follows:

The clerk has agreed that the name of one Friend transferring need not be included by name at this point.

The manner of membership transition from General Meeting to Quakers in Scotland is unique to Scotland by the nature of the Scottish Charitable Incorporated Organisation (SCIO). This stipulates that members must apply to transfer to the new charity, and that if they do not, their membership lapses. The only way membership of the Religious Society of Friends is held, is through an Area Meeting, which for this purpose

is what Quakers in Scotland is. The only other way to retain such membership is to transfer to another Area Meeting.

We are adopting a new email provider with the list of those receiving email and contact from Quakers in Scotland restricted to those having transferred their data permission. We are also moving towards a new database to give us more flexible access to data and information.

QiS 25/11/16 Young Friends with us today

Mary Troup, our Children & Young People's Advocate Support, has explained that we have some young Friends joining us during the day, outside sessions.

QiS 25/11/17 QiS Trustees Report and QiS 2026 Budget

We have received an oral update from Elizabeth Allen, a co-clerk of our Foundation Trustees.

The team that forms our Trustees has concentrated upon two main areas: the work connected to the transfer to Quakers in Scotland (QiS) of those Quaker charities that are laying them themselves down, and putting into place the documents, policies and systems which enable QiS trustees to carry out their service effectively.

Regarding the charities, General Meeting for Scotland Trustees report that that charity is in the final stages of being wound up. Today, East Scotland, North Scotland and West Scotland Area Meetings lay themselves down as Quaker bodies transferring their Quaker area meeting responsibilities to QiS. The legal transfer agreements have been signed by the trustees of these Area Meetings and their assets are in process of being transferred to QiS. When this is complete the three charities will be dissolved.

Dundee Friends Property Trust expects to transfer to QiS in the New Year.

We receive minute 25/10/08 from our Foundation Trustees, which reads as follows:

QiS Property Committee

We have identified an urgent need to set up a Property Committee and ask Quakers in Scotland to do this.

We ask Kate and Chris to prepare draft Terms of Reference for this committee, based on the Terms of Reference for the BYM Finance and Property Committee, and the existing draft QiS General Memorandum of Understanding.

We send this minute to Quakers in Scotland.

Elizabeth Allen and Adwoa Burnley, co-clerks

We agree to this and ask our Nominations Committee to bring in the names of suitable numbers of committee members and a clerk, to the Trustees directly. The Property Committee will be appointed by and report to Quakers in Scotland Trustees and should include two trustees as members.

Our treasurer, Kate Gulliver, has spoken to the draft interim budget for 2026 (Paper D). The budget proposes an expenditure of £73,491 balanced by projected income of £73,500. We accept this interim budget noting that changes may occur as we settle to the new ways of working. We ask Trustees to facilitate a review of all grants and donations for 2026 for a future QiS meeting.

We ask Nominations Committee to bring in the names of two further assistant treasurers to make a treasury team of four. This would both strengthen the team and provide a good basis for succession planning.

QiS 25/11/18 Parliamentary Engagement Working Group report

We receive the quarterly report of our Parliamentary Engagement Working Group (Paper Ei), together with the proposals for PEWG's three year priorities 2026-2028 (Paper Eii) and Carolyn Burch, co-convenor, has spoken to them.

We are pleased to hear Lucy Le Roux is settling into her role as Interim Parliamentary Engagement Officer PEO, as Sarah Komashko has begun her parental role. Lucy is undergoing her Quakers in Britain training, but has already begun sending her first email updates.

The online 'special meeting' about PEWG work was held on 23rd October, with a view to strengthening the group membership and looking towards new Convenors being appointable in the near future. The meeting was well supported and brought in a number of expressions of interest which have been passed to Nominations Committee. It is encouraging that as a result the Working Group is feeling very positive about the future of PEWG and its work.

Peacebuilding work has included participating in the launch of the Scottish Peace Platform, which we are recommended to join as full members (presently at no cost). We agree to do this and appoint Joyce Taylor (Glasgow Local Meeting) as our contact. Other peacebuilding work involved 'Manifesto meetings' with the main political parties, specifically human rights filters for arms company funding grants, and the multiple benefits of peace education. The PEO also plans to meet with Amnesty International on how to take forward the dialogue(s) on funding for arms with ministers and Scottish Enterprise. Other highlights of recent or upcoming work included meeting with the SNP manifesto-writing team on loss and damage funding; peace education; funding to arms companies; clear public engagement on, and strong implementation of climate policy. Two members of

the Community Justice Working Group (SQCJWG) also attended and spoke about restorative justice and prison reform.

PEWG also worked with others to provide text for the Loss and Damage motion/debate led by Nicola Sturgeon due on 5 November. For the Scottish parliamentary elections in May next year, PEWG/PEO will be briefing Quakers in Scotland and will be providing materials to Friends to facilitate their contacting their MSPs and election candidates. PEWG and SQCJWG also hope to meet with Quaker MSP Alex Cole-Hamilton to discuss renewable energy and green skills; Loss and damage funding and issues of prison policy in relation to the Liberal Democrat manifesto and to advise us on good approaches for Quaker advocacy with the cohort of new MSPs after the election.

We thank the PEWG for its work on our behalf.

Qis 25/11/19 Parliamentary Engagement Working Group three-year priorities 2026 - 2028

Richard Raggett, co-convenor of the Parliamentary Engagement Working Group (PEWG), has spoken to Paper Eii on the proposals for the PEWG priorities for the period 2026-2028.

The PEWG has consulted with Area Meetings and Friends across Scotland during this year and Paper Eii takes account of what was heard. In practical terms, the upcoming 2026 Parliamentary election will be a 'priority' for our PEO over the next 6 months, though within the parameters of our agreed priority areas. The current priorities are Climate Justice, Peacebuilding and Economic Justice (including land reform). All Area Meetings expressed support for the continuation of our current priorities, and we agree to this. We also support this context in which they should operate:

- advocating for truthfulness, integrity and listening, encouraging MSPs to follow their consciences and to work cross-party, recognising that their work is demanding and difficult
- ensuring our advocacy is well informed and is a representative recognisably Quaker voice
- working closely with the Community Justice Working Group and with other allies

In addition, some questions were raised from the consultation, which the group needs to apply in all our advocacy:

- How to mitigate conflict when issues are presented in extremist or divisive ways.
- How to focus on where we can make the most difference / change things.

The continuing priority headings allow flexibility according to parliamentary business and PEWG capacity. PEWG have identified particular focus points

(framed via our Quaker testimonies) which will evolve, but give strong guidance on how to frame the three priorities. We endorse these as listed below.

The overarching priority for our PEWG work, at a time of a rise in extremism and divisiveness, is the concern of truth and integrity in public life. This concern includes speaking out for freedom of expression and assembly where these are under increasing restriction.

Climate Justice

Likely focus points:

1. Supporting continued loss and damage funding (equality; sustainability)
2. Continuing to ask for truthfulness in climate policy (truth and integrity)

Peacebuilding

Likely focus points:

1. Continued discussions over Scottish Enterprise funding for arms/components (peace; truth and integrity)
2. Advocacy where opportunities arise to support ongoing development of Peace Education principles (peace; equality)

Economic justice

Likely focus points:

1. Relates to climate justice - keeping equality and simplicity in mind when advocating on climate policy (fuel poverty, sustainable economy)
2. Working closely with the Community Justice Working Group on advocacy openings (equality)

We thank the PEWG for its careful consultation and look forward to regular reports on how the priorities guide the work. Friends are encouraged to approach the Group if they have witness concerns they are working upon.

QiS 25/11/20 Scottish Quaker Community Justice Working Group

Further to minute QiS 25/09/14, Kate Philbrick, clerk of the Scottish Quaker Community Justice Working Group (SQCJWG) has spoken to its annual report (Paper Fi).

Over the last year, the Working Group has continued to work to further the Quaker testimonies of peace, equality and justice, seeking growing points to bring about a just and compassionate society. It recognises that the inequalities and inadequacies in our society contribute hugely to the violence within it, the harms done and offences committed. Kate has indicated in the written report where the Working Group is in relation to its objectives of the Working Group (minute GMS 24/11/16 refers).

Much emphasis has been put on working more closely with the wider Scottish Quaker Community Justice Network, ensuring a two-way communication, for example in producing the Working Group's documents and coordinating monthly discussions. Mike Nellis's talk on giving evidence to the Sentencing Commission in a personal capacity, was a network highlight in October and there are two interesting talks planned: Angela Collins on Women in prisons and the effect on their children (November 2025) and Laurena Emmerson and a colleague from the Children and Young People Centre for Justice will talk on Restorative Justice (December 2025). The Working Group has also held a successful online event during "Prisoners Week" primarily for Quakers based in Scotland. This involved Ben Jarman (2024 Swarthmore lecturer) answering questions, followed by talks from Maggie Chapman MSP, Green Party Spokesperson on criminal justice (Aberdeen Quaker attendee) and Mike Nellis (Working Group and Network member).

The Working group also represents QiS in communicating discerned Quaker views on community justice issues to other bodies and to the Scottish public. It works closely with the Scottish Prison Chaplaincy in planning "Prisoners Week" events, with this year's Zoom event being held on 19th November (Paper Fii is the flier). The Very Reverend Andrew McLellan (a former moderator of the Church of Scotland and former Chief Inspector of Prisons) will chair the session, and the Howard League for Penal Reform and Kate Philbrick will approach the need for penal reform from different perspectives. The ensuing discussions will give an opportunity for all attending to have space for reflection and to shine a light on how justice can be delivered compassionately with a more creative and appropriate response to crime. The Group feels offering quiet spaces is maybe Quakers' greatest gift. The Working Group and Network members also supported a delayed Quaker Week launch of the book about the Barlinnie Special Unit on October 22nd, hosted by Alastair Macintosh at the Gal Gael Foundation.

The Working Group has also successfully joined with the Parliamentary Engagement Working Group for joint work, and has also made good use of the Parliamentary Engagement Officer's expertise and contacts.

As a result of responding so often to consultations, the working Group feels that it would be helpful if it created a simple document which we could share with Quakers, the public, policy makers and others, setting out our vision. We encourage this approach. The current title is; *Changing How We Respond to Crime in Scotland, from a Quaker Perspective. Re-imagining society as fairer, more caring, forgiving and compassionate*. Its themes are:

1. Prisons aren't working, our overcrowded prisons have social and financial costs.
2. There are effective and restorative humanising alternatives to prison and other ways of delivering justice.

3. Alternatives to (over-) imprisonment works elsewhere - why not in Scotland?
4. We need to consider social justice, our communities, and the causes of crime. Crime is a community issue, not just something about the offender.
5. How can Scotland change now?
Scotland has a track record of change.
6. The Quaker perspective.

The Working Group has also worked to support interfaith chaplaincy within the justice system with continuing dialogue with the Chaplaincy advisors and in jointly planning a retreat day for facilitator chaplains in late November at Glasgow Meeting house on the theme of Sanctuary. Three of the Working Group have been going into HMP Addiewell to support the chaplain there. He has brought together a group of “elders”, who are prisoners who work to support other prisoners. There is scope for offerings such work in other prisons.

In March last year, the Working Group gave advice to General Meeting on Orders for Lifelong Restriction as being comparable, but not the same, as the Imprisonment for Public Protection sentences on which Meeting for Suffering had been investigating. Minute GMS 24/03/12 refers. Although originally the Working Group advised “At this stage we do not recommend that Scottish Quakers should prioritise the revocation of the OLR legalisation; we would align with other organisations highlighting operational or procedural issues with OLRs should these arise,” there has now been some concern about their application. The Working Group is aware of the psychological impact of indeterminate sentences, and the limited employment opportunities for offenders released on indeterminate sentences, particularly with the experience of living under the threat of recall. This is similar to the issues faced with IPP sentence in England. Balanced against this the Working Group reflects that without indeterminate sentences and opportunities for release, which are deemed to be able to be safely managed, sentencers might impose even longer determinate sentences. Therefore, currently the SQCJWG cannot definitively oppose indeterminate sentences; and will continue to monitor the situation and include this issue in the broader debate about the future of sentencing.

We have had questions and comments and Kate Philbrick and Chris Holman

We are glad to hear how the Working Group is approaching and expanding its work on our behalf. We all have responsibility to change the prevailing punitive approach to offending. It was helpful to hear the ministry given by our travelling ministers that highlighted the basis from which we work in following the leadings of the Spirit. We remember the humanity of all as equals in having that of God within them and that guides our dealings.

We move forward together, trusting in the leadings of the Spirit that are available to us if we listen. Worship is the ground of our being, and all our Quaker structures are to that end. It is from right worship that our faith and witness comes, and our structures are to maintain that.

We have work to do to translate the changes into strong community that can look after its own and we use this opportunity to find ways to connect and be relevant with our business methods and decision making. In the end it is up to us all.

We note that South East Scotland Area Meeting intends to make a decision in principal over its relationship with Quakers in Scotland at its meeting on 19th January 2026.

25/11/23 Transition from General Meeting for Scotland to Quakers in Scotland: Memoranda of Understanding

Papers Hiii a & b from the Quakers in Scotland Co-ordinating Group set out draft Memoranda of Understanding (General & Property).

A memorandum of understanding (MOU) describes who does what within Quakers in Scotland (QiS), whether by QiS itself or it's trustees, or its constituent Local Meetings (LMs). It seeks to provide clarity about

- Who does what particularly in areas of overlapping responsibility
- What should be reported to whom
- Legal responsibilities of the trustees and where these are delegated to QiS or LMs.

Quakers in Scotland (QiS) functions as an Area Meeting for its constituent LMs, and *Quaker faith & practice* advises that:

Each local meeting should agree with its area meeting the duties and responsibilities which the local meeting undertakes on behalf of the area meeting. This agreement should be formally recorded as part of a memorandum of understanding. The local meeting should report regularly, as required, to its area meeting on the discharge of these responsibilities. In the case of smaller meetings which are not able to carry forward all the responsibilities listed above, the recorded agreement should make clear the work that they are able to do themselves and what is done in co-operation with another local meeting. (Qfp 4.34)

Trustees are responsible for the assets of Quakers in Scotland, which in law includes all the assets of its constituent local meetings, and for the stewardship of its resources; in practice day-to-day decisions and the running of Local Meetings are left to local Friends.

These documents give guidance on who has responsibility for what. They aim to prevent misunderstandings and oversights, and are tailored to the circumstances of each meeting. They are not legal documents. Local Meetings (LM) and the Quakers in Scotland (QiS) are mutually interdependent. We are part of the same community and share the same overall purpose. The General MOU describes how responsibilities are shared between local meetings, QiS, and QiS trustees - who does what. Property and Financial arrangements are dealt with in more detail in the Property MOU and separate documents.

We accept the working drafts on the basis that minor adjustments can be made before the General and Property MOUs are agreed between Trustees and Local Meetings.

We ask Friends with comments on the text to send them to the Trustees.

The current MOU will be available on the website.

We ask that agreed documents also be signed by the Quakers in Scotland clerk.

The Memorandum of Understanding will be reviewed every five years, or earlier if an LM or Trustees feel this would be helpful and agreed to re-issue the memoranda to all local meetings.

25/11/24 Transition from General Meeting for Scotland to Quakers in Scotland: Intermediate Meetings

The Quakers in Scotland Co-ordinating Group has prepared Paper Hiv on how Intermediate Meetings might work. This version is the latest draft following consultation. Intermediate meetings could take on many of the things that are currently or have been done at Area Meetings, in a manner that is flexible and not constrained by current geographical boundaries. The paper should be referred for guidance when setting up intermediate meetings.

An intermediate meeting is a meeting of Friends from a number of different worshipping communities who come together, for building community and/or sharing business.

All Intermediate Meeting would be for regional community building, such as residential meetings or other events shared between meetings or open to Friends from different meetings. Some would not undertake QiS business and might be occasional or regular.

Other Intermediate Meetings could include at least some business for QiS, in which case they should be open to all Friends within QiS who wish to attend. They would appoint clerks and make minutes. Minutes on business undertaken for QiS should be recorded at the next QiS full meeting. Such intermediate meetings could be occasional or regular, and some former area meetings might wish to continue as intermediate meetings under a different name.

We ask the Quakers in Scotland Co-ordinating Group to indicate, in an updated paper, a process for operating intermediate meetings.

Working in and with intermediate meetings is crucial Quakers in Scotland's order and needs more understanding by Friends. This will also come in trying them out. We will return to the manner in which intermediate meetings work, reflecting on our shared experience as we evolve our role and function.

25/11/25 Transition from General Meeting for Scotland to Quakers in Scotland: Eldership and Pastoral Care

The Quakers in Scotland Co-ordinating Group has brought to us paper Hv on how eldership might work within Quakers in Scotland where area meetings have been laid down. The pastoral care paper is still in preparation but we will come to it early next year.

We adopt the Eldership paper as helpful guidance.

From it, we agree to form a QiS Eldership Group, normally meet up to six times a year and open to every appointed elder in Scotland. At least one elder from each recognised Local Meeting and representatives coming from Local Meetings that have adopted a corporate eldership or spiritual care model should attend these meetings.

The QiS Eldership group will be clerked by an appointed elder, previously appointed elder, or a team of elders. These Friends will be nominated by Quakers in Scotland Nominations, in consultation with the QiS Eldership Group, and appointed by Quakers in Scotland. We ask the QiS clerks to arrange a first meeting of current elders to

facilitate this. We ask that a similar meeting be held for current pastoral care Friends whilst we wait for the final paper from the Co-ordinating Group.

The responsibility of the QiS Eldership Group is to:

- Provide a forum where concerns can be raised and advice can be sought.
- Provide support and learning for new elders.
- Be a point of contact for Friends resident in meetings that do not have appointed elders.
- Promote best practice and enable collaboration across meetings.
- Work to support combined approaches to learning for all Friends.
- Coordinate support for newcomers across Scotland.
- Work with the QiS Pastoral Care Group, having joint meetings when useful.

QiS Eldership Group may set up subgroups for particular purposes, reviewing longer serving ones regularly.

We adopt the following procedure for the appointment of elders:

Names of Friends to serve as elders would be forwarded from local meetings to the QiS Nominations Committee. This committee would consider geography, numbers of Friends that the elders served, life experience of those Friends, also checking on safeguarding and PVG where relevant. The appointments would be made by QiS to emphasise that they serve the whole body and their responsibilities go beyond the Friends' local meeting or worshipping community. The QiS nominations committee would work with the local meetings to ensure that each meeting has the eldership cover that they require.

25/11/26 Transition from General Meeting for Scotland to Quakers in Scotland: Committee structure and appointments

The Quakers in Scotland Co-ordinating Group has forwarded Paper Hvii on a possible committee and appointments structure, showing how Local Meetings, Intermediate Meetings and QiS could appoint committees and role-holders in an integrate manner. This is backed up in the paper by useful diagrams. Such a structure will necessarily evolve and we will consider this in stages. Some of the suggestions in the paper are already in operation or have been asked for – such as the QiS Trustees and the finance and property committees. Nominations Committee we will consider separately.

There is immediate need to bring together Friends appointed to roles transferred from area meetings that have been laid down. This is where action has not already been taken.

We ask the clerks to arrange a meeting with registering officers to ensure we have sufficient for QiS and that they are properly registered.

We ask trustees to work with Friends appointed as treasurers, safeguarding officers and health and safety officers.

25/11/27 Transition from General Meeting for Scotland to Quakers in Scotland: QiS Nominations Committee

We receive Paper Hviii, *Ideas for QiS Nominations Process*, from Marilyn Higgins, clerk to QiS Nominations Committee. This paper expands on the suggestions for a Nominations Committee and its appointment from the Quakers in Scotland Co-ordinating Group has forwarded Paper as seen in paper Hvii.

Both papers stress how the nominations process emphasises the spiritual act of discernment at its heart. "It is a practical application of our faith with a firm spiritual foundation arising from our testimonies. Discernment can be deep, prayerful, careful, powerful."

Currently QiS Nominations Committee has a clerk, an assistant clerk and representatives from the previous and current area meetings. We encourage Nominations Committee to meet soon with the Nominations Committee members transferred from former area meetings, with this enlarged body having authority to form an interim ongoing Nominations Committee with these Friends.

We endorse the approach to a QiS nominations process as shown in paper Hviii and ask the interim Nominations Committee to work with local and intermediate meetings to take forward the ideas listed in the paper. We ask the interim committee to bring us a method for appointing future QiS Nominations Committees.

We will return to consideration of paper Hviii as we are short of time today. We thank Marilyn and the current QiS Nominations Committee, and the Co-ordinating Group, for their work to establish our nominations process.

QiS 25/11/28 Tabular Statement for 2025

QiS 25/11/29 Upcoming Business

We will only meet again in 2025 for a brief meeting if there are appointments to be made. The next meeting will be online on 7th February 2026 in the evening. We envisage the main business for the following meeting on Saturday 28th February to be a continuation with our transition arrangements to Quakers in Scotland, and also

to include a Meeting for Sufferings report, a report from our Trustees and a consideration of our ecumenical and interfaith work.

QIS 25/11/30 Concluding minute

The *Quaker faith & practice* quotation read in our worship (William Dewsbury (29.19) asks us to wait in the light. This is the final entry in our present 'red book', and the compilers of *Quaker faith & practice* intended the book to be seen as a continuing circle, so that this entry leads us back to chapter 1, *Advices and queries*, that turns us examine ourselves and our communities continually. Chapter 1 begins "As Friends we commit ourselves to a way of worship which allows God to teach and transforms us. We have found corporately that the Spirit, if rightly followed, will lead us into truth, unity and love: all our testimonies grow from this leading".

We record our thanks to South East Scotland Area Meeting and Central Edinburgh Local Meeting Friends for being our hosts today, for all the arrangements for our venue and their hospitality that enabled this hybrid meeting. We also thank David Sterratt and Clive Potter for Zoom hosting today.
