


QUAKERS IN SCOTLAND

QiS 26/02/13 Consideration of support for American Friends' Service Committee

Further to minute 26/01/7 From Glasgow LM asking QiS to consider a letter of support from QiS to American Quakers we agree to ask our clerks to contact Friends World Committee for Consultation World Office to ask if there is anything useful we can do and to write to The American Friends Service Committee on behalf of QiS.

QiS 26/02/14 Consideration of name for Intermediate Meetings

We are grateful for all the work that has gone into creating, supporting and enabling QiS to exist. Many Friends have worked tirelessly over many years to guide, inform and reassure all friends in Scotland during this adventurous transition. One part of this work that we have heard needs a re-think is the name for 'intermediate' meetings. As we began our discernment it became clear that we all need more time to sit with where we are and there is a feeling that we are content to do so. We agree to keep using the term Intermediate Meetings for the time being, wait until QiS Trustees and SESAM trustees have moved forward with their discernment and return to this at a future QiS meeting. Meanwhile we are encouraged to take this discernment to our Local Meetings and consider it with Friends of all ages.

QiS 26/02/15 Concluding minute

We give thanks for today's meeting for worship and separate, hoping to meet again on Sat 28th February should nothing occur to prevent. This next meeting of QiS will be blended and held in the A.K. Bell Library in Perth. Information with a draft agenda, papers and information on how to register will be circulated prior to the meeting as will draft minutes closer to the meeting.

NOTES

As per the above agreed minute, the document below (which is on the QiS website) is purely a start at what we mean by Intermediate Meetings at this point. Please bear in mind the long hours of work that has got us this far. For which I am very grateful. I keep it here for information.

I was filled with joy at the enthusiasm shown today by Friends across Scotland in minute 12 in sharing all the upcoming events.

What is an Intermediate Meeting?

An intermediate meeting is a meeting of Friends from a number of different worshipping communities who come together. It might be for worship, learning, to eat, walk, anything that enables them to get to know one another and build community.

Current examples include:-

- Wigtown, Castle Douglas and Dumfries meetings who come together in**

Castle Douglas every fifth Sunday for Meeting for Worship.

- Island and Coastal Friends from the west coast who worship together online every Sunday evening and meet once a year for a residential weekend.
- Pluscarden was the annual residential weekend for NSAM. They have arranged for it to continue and have appointed Friends to arrange this year's event.
- ESAM Friends have been operating their AM on a 'care and maintenance' basis. Their LMs have arranged events and invited Friends from the other LMs to join them.

• Dunblane LM invited the Swarthmore lecturer, Emily Provance, to speak and invited Friends from the neighbouring LMs who came from three different AMs.

Many of these Occasional Intermediate meetings need to do no business; for those that do, it is simply for internal organisation, like appointing people to plan the next meeting. This is not QiS business.

It is possible that one of the AMs might want to continue meeting regularly. This too brings members of different worshipping communities together.

In the new organisation, this would be a Regular Intermediate Meeting. Such a Regular Intermediate Meeting would appoint a Friend as a clerk to help them operate, though it would be important that any such appointments did not limit the ability of Friends from these communities to serve in QiS roles. This sort of Regular Intermediate Meeting could want to do business. Some of it could be things relating just to its constituent communities, this would probably not be QiS business. They might also want to take some business relating to responsibilities that are specifically QiS business. QiS may decide to work with them to draw up an MOU listing the kinds of QiS business it would be appropriate for them to do. When the community subgroup asked Friends if there was business that might be best done in groupings smaller than the national body, membership and appointments were frequently mentioned. For this to happen, the necessary provisos are that the agenda of these Intermediate Meetings should be advertised across QiS in case another QiS Friend is led to attend, and that an Intermediate Meeting takes no decision that lays an obligation on other members of QiS. The minutes of these items of business are QiS minutes and should be forwarded to QiS so they can be accepted at the next QiS meeting.

Although the focus of an Occasional Intermediate Meeting is on community building, it is possible that there might be an item of QiS business that it wished to take itself. The most likely would relate to membership or an appointment. An occasional Intermediate Meeting would not be set up for the purpose of taking such business; but one set up for a different purpose might decide it felt right to take an occasional item of business. In order to ensure this is rightly held, there is a list of requirements which might be summarised on a proforma so they can easily be checked through. This is largely something that can be done by an administrator, though the final authority would need to come from a QiS clerk.

Since Friends would not be coming together as a community at an Area Meeting, it is to be hoped that community building would be supported by a

growing number of occasional Intermediate Meetings. Initially examples of an occasional Intermediate Meeting taking business is expected to be rare.

The list of the NSAM appointments was to be appended to the November minutes and space was left for it to be included in minute 25/11/22. It doesn't need to be minuted again as we agreed to put it there when NSAM sent it in. That means all the transferred appointments are in one place. This has been done. We ask our administrator to attach it to the relevant minutes on our website.

26/01/7 Support for American Friends (minute from Glasgow LM)

In view of the political situation in the USA, where brutal methods are being used to remove immigrants, and particularly the shooting of protestors in Minneapolis, it has been suggested that we might like to express our support for American Friends in two ways: by holding a special collection for the American Friends' Service Committee, and by sending them a minute of solidarity.

We have heard that AFSC has a long track record of supporting immigrants and refugees, and are very willing to hold a special collection for them. We ask ████ to speak to it and prepare information for the newsletter, and ████ to deal with the money. Rather than remove one of our chosen charities from the monthly list, we agree to hold an additional special collection on 8 March, as a month which has five Sundays in it. Our treasurer is happy with this arrangement.

As regards the minute of solidarity, we feel that this applies both at a local and national level. We accordingly ask our Clerks to send a minute to Friends in Minneapolis, and ask Quakers in Scotland to consider sending a minute of support and solidarity to Friends in the USA.

We ask Elders to see what work is already being done by Scottish Friends, including the Parliamentary Engagement Working Group, and to consider contacting Woodbrooke to see if they have resources we could use in considering how we live our faith in such dark and difficult times.
