We have heard from Phil Lucas about his experiences earlier this year as an ecumenical accompanier with the World Council of Churches programme EAPPI.

Phil has given us a vivid account of the impact of the Israeli occupation on the lives and livelihoods of Palestinians, the growth of illegal settlements and the building of the separation wall. We have been deeply moved by the insights Phil has given us into the suffering of Palestinian families as they attempt to carry on their normal lives while subjected to land grabs, house demolitions and the indignities of checkpoints. He has also described his meetings with members of Israeli peace organisations. We are urged to do whatever we can to raise public awareness of these issues.

Min. 9 The work of the Scottish Churches Parliamentary Office

We have welcomed Chloe Clemmons, the Scottish Churches Parliamentary Officer, as our speaker. The Office was established by a broad range of Scottish churches in 1999 with the task of building a fruitful relationship initially with the Holyrood parliament, and now also with that in Westminster.

It operates in two main ways: building knowledge through providing briefings, and building capacity by offering practical advice and help to churches and groups lobbying politicians.

Chloe has reminded us of the process by which legislation in Holyrood is passed, and given us examples of effective influence over the outcome in matters such as climate change and criminal justice.

The current political landscape, with a coalition administration in Westminster and a minority administration in Holyrood, has brought a measure of unpredictability to political life. Regular communication channels become particularly important at such a time. The relationship does not always have to be about lobbying. However, the impending comprehensive spending review, welfare reform and the elections to Holyrood next May all offer significant opportunities for shaping the impact of political decisions upon our society.

In a group exercise we have experienced some of the dynamics of lobbying, what it can mean to be a 'seed of change'.

We thank Chloe for her presentation and for stimulating us to think afresh about our political engagement.
